1 Included Applications

Master Agreement Amendment #6 requires enhanced service level measures under **Article II Performance Criteria Contractual Principles, Section 2.07 (c), Service Level Name, Application Reliability – Existing TexasOnline Solutions**. The monthly ID-03 Application Service Level Report in effect ahead of the executed amendment lists those applications identified as Existing Solutions; however, there also are other newer applications that coexist on the same framework as a number of the applications in the existing category and, therefore, would be affected joining by any service issues experienced. The respective applications, identified as Original Framework Services and as Renewal License Framework Services* and, in accordance with Amendment #6, are to be collectively reported under a single Service Level measure in the ID-03 Application Service Level Report. The below tables, Table 1 – Original Framework Services and Table 2 – Renewal License Framework Services, list the respective applications to be included in the consolidated reporting, for as long as they remain active and in commission.

Those Existing TexasOnline Solutions applications not categorized as Original Framework Services and Renewal License Framework Services applications will continue to be reported individually in the ID-03 Application Service Level Report.

*Certain applications (“Original Framework Services and the Renewal License Framework Services”) are Texas.gov application instances which were developed and implemented as required by provisions of Senate Bill 974, 76th Legislature (Act of June 18, 1999, ch. 730, 1999 Tex.
