

**AMENDMENT NUMBER 2  
TO  
CONTRACT NO. DIR-SDD-1722  
BETWEEN  
THE STATE OF TEXAS, DEPARTMENT OF INFORMATION RESOURCES  
AND  
SIGMA SURVELLIANCE, INC. DBA STS 360 as successor to STS 360, LLC**

This Amendment Number 2 to Contract Number DIR-SDD-1722 (“Contract”) is between the Department of Information Resources (“DIR”) and SIGMA SURVELLIANCE, INC. DBA STS 360, LLC as successor to STS 360, LLC (“Vendor”). DIR and Vendor agree to modify the terms and conditions of the Contract as follows:

1. By this Amendment Number 2, SIGMA SURVELLIANCE, INC. DBA STS 360 expressly assumes all rights, obligations and liabilities, past, present, and future, under this Contract, and will hold DIR harmless from any claim by STS 360, LLC.
2. SIGMA SURVELLIANCE, INC. DBA STS 360 hereby represents to DIR that it owns the Contract and agrees to perform all duties and obligations to be performed by Vendor under the above-mentioned Contract to the same extent as if it had been an original party thereto. SIGMA SURVELLIANCE, INC. DBA STS 360 hereby represents to DIR that by the effective date of this amendment, that it is or will be registered as a Texas Vendor, with all necessary Texas taxpayer identification numbers with the Comptroller of Public Accounts and be in good standing with that office, and otherwise be authorized to do business with the State of Texas.
3. **Appendix A. Standard Terms and Conditions For Product and Related Services Contracts**, is hereby restated in its entirety and replaced with the attached Appendix A. Standard Terms and Conditions For Product and Related Services Contracts dated **12/17/2012**.
4. **Appendix C – Pricing Index** is hereby replaced in its entirety with **Appendix C – Pricing Index** dated 6/21/2013, as attached to this Amendment Number 2.

All other terms and conditions of the Contract by all previous amendments, not specifically modified herein, shall remain in full force and effect. DIR retains the right to require further amendment to the Contract to update its terms and conditions as may be reasonable, necessary or required. In the event of conflict among the provisions, the order of precedence shall be this Amendment Number 2, then Amendment Number 1, and finally Contract DIR-SDD-1722.
