

**AMENDMENT NUMBER 1
TO
CONTRACT NO. DIR-SDD-1829
BETWEEN
THE STATE OF TEXAS, DEPARTMENT OF INFORMATION RESOURCES
AND
PCMG, Inc. dba PCM Gov, Inc.
formerly PC Mall Gov, Inc.**

This Amendment Number 1 to Contract Number DIR-SDD-1829 (“Contract”) is between the Department of Information Resources (“DIR”) and PCMG, Inc. dba PCM Gov, Inc. formerly PC Mall Gov, Inc. (“Vendor”). DIR and Vendor agree to modify the terms and conditions of the Contract as follows:

1. DIR acknowledges the name change of the Vendor from PC Mall Gov, Inc. to PCMG, Inc. dba PCM Gov, Inc. effective January 1, 2013. DIR shall change the contract documents hereafter to PCMG, Inc. dba PCM Gov, Inc.
2. **Contract, Section 1. Introduction, A. Parties** is hereby restated in its entirety as follows:

A. Parties

This Contract for products and related services is entered into between the State of Texas, acting by and through the Department of Information Resources (hereinafter “DIR”) with its principal place of business at 300 West 15th Street, Suite 1300, Austin, Texas 78701, and PCMG, Inc. dba PCM Gov, Inc. (hereinafter “Vendor”), with its principal place of business at 14120 Newbrook Drive, Suite 100, Chantilly, VA 20151-2273.

3. **Contract, Section 4. Pricing, G. Travel Expense Reimbursement** is hereby restated in its entirety as follows:

G. Travel Expense Reimbursement

Pricing for services provided under this Contract are exclusive of any travel expenses that may be incurred in the performance of those services. Travel expense reimbursement may include personal vehicle mileage or commercial coach transportation, hotel accommodations, parking and meals; provided, however, the amount of reimbursement by Customers shall not exceed the amounts authorized for state employees as adopted by each Customer; and provided, further, that all reimbursement rates shall not exceed the maximum rates established for state employees under the current State Travel Management Program (<http://www.window.state.tx.us/procurement/prog/stmp/>). Travel time may not be included as part of the amounts payable by Customer for any services rendered under this Contract. The DIR administrative fee specified in Section 5 below is not applicable to travel expense reimbursement. Anticipated travel expenses must be pre-approved in writing by Customer.

4. **Contract, Section 5. DIR Administrative Fee, B)** is hereby restated in its entirety as follows:

B) All prices quoted to Customers shall include the administrative fee. DIR reserves the right to change this fee upwards or downwards during the term of this Contract, upon written notice to Vendor without further requirement for a formal contract amendment. Any change in the administrative fee shall be incorporated in the price to the Customer.

5. **Contract, Section 6, Notification**, is hereby restated in its entirety as follows:
