This Amendment Number 2 to Contract Number DIR-SDD-2221 (“Contract”) is between the Department of Information Resources (“DIR”) and Netronix Integration, Inc. formerly HSP Systems, Inc. (“Vendor”). DIR and Vendor agree to modify the terms and conditions of the Contract as follows:

1. Netronix Integration, Inc. represents and warrants that it has acquired HSP Systems, Inc. DIR acknowledges the acquisition and the name change for this Contract from HSP Systems, Inc. to Netronix Integration, Inc. with its principal place of business at 2170 Paragon Dr. San Jose, CA 95131. DIR agrees to change all contract files to the new name.
2. Netronix Integration, Inc. hereby agrees to perform all duties and obligations to be performed by Vendor under Contract DIR-SDD-2221 to the same extent as if it had been an original party thereto.
3. Netronix Integration, Inc., also represents that it is not currently delinquent in the payment of any franchise tax owed the State of Texas and is not ineligible to receive payment under §231.006 of the Texas Family Code and acknowledges the Contract may be terminated and payment withheld if this certification is inaccurate.
4. Netronix Integration, Inc., hereby represents it is authorized to do business in the State of Texas and is in good standing with the Comptroller of Public Accounts.
