This Amendment Number 5 to Contract Number DIR-TSO-2538 (“Contract”) is between the Department of Information Resources (“DIR”) and HP Inc. formerly Hewlett-Packard Company (“Vendor”). DIR and Vendor agree to modify the terms and conditions of the Contract as follows:

1. DIR acknowledges the name change to HP Inc. (doing business as HP Computing and Printing Inc.) from Hewlett-Packard Company, with its principal place of business at 1501 Page Mill Road, Palo Alto, CA 94304-1185. Effective date of change is November 1, 2015. DIR agrees to change all contract files to the new name.
2. HP Inc. hereby agrees to perform all duties and obligations to be performed by Vendor under Contract DIR-TSO-2538 to the same extent as if it had been an original party thereto.
3. HP Inc. also represents that it is not currently delinquent in the payment of any franchise tax owed the State of Texas and is not ineligible to receive payment under §231.006 of the Texas Family Code and acknowledges the Contract may be terminated and payment withheld if this certification is inaccurate.
4. HP Inc. hereby represents it is authorized to do business in the State of Texas and is in good standing with the Comptroller of Public Accounts.
