This Amendment Number 2 to Contract Number DIR-TSO-2687 (“Contract”) is between the Department of Information Resources (“DIR”) and ConvergeOne, Inc. formerly North American Communications Resource, Inc. (NACR) (“Vendor”). DIR and Vendor agree to modify the terms and conditions of the Contract as follows:

1. DIR acknowledges the name change to ConvergeOne, Inc. formerly North American Communications Resource, Inc. (NACR), with its principal place of business at 3344 Highway 149, Eagan, MN 55121. Effective date of change is January 15, 2016. DIR agrees to change all contract files to the new name.
2. ConvergeOne, Inc. hereby agrees to perform all duties and obligations to be performed by Vendor under Contract DIR-TSO-2687 to the same extent as if it had been an original party thereto.
3. ConvergeOne, Inc. also represents that it is not currently delinquent in the payment of any franchise tax owed the State of Texas and is not ineligible to receive payment under §231.006 of the Texas Family Code and acknowledges the Contract may be terminated and payment withheld if this certification is inaccurate.
4. ConvergeOne, Inc. hereby represents it is authorized to do business in the State of Texas and is in good standing with the Comptroller of Public Accounts.
5. **Appendix C – Pricing Index** is hereby restated in its entirety and replaced with Appendix C – Pricing Index attached hereto.
6. **Appendix D – Maintenance Service Agreement** is hereby restated in its entirety and replaced with Appendix D – Maintenance Service Agreement attached hereto.

All other terms and conditions of the Contract as amended, not specifically modified herein, shall remain in full force and effect. In the event of conflict among the provisions, the order of precedence shall be Amendment Number 2, then Amendment Number 1, and then the Contract.
