This Amendment Number 2 to Contract Number DIR-TSO-3043 (“Contract”) is between the Department of Information Resources (“DIR”) and Xerox Corporation. (“Vendor”). DIR and Vendor agree to modify the terms and conditions of the Contract as follows:
