

Amendment Number 1

This Amendment Number 1 to Contract Number DIR-TSO-3149 (“Contract”) is between the Department of Information Resources (“DIR”) and Carahsoft Technology Corporation. (“Vendor”). DIR and Vendor agree to modify the terms and conditions of the Contract as follows:

1. Contract, Section 1. Introduction. C. Order of Precedence is hereby amended as follows:

This Contract; Appendix A, Standard Terms and Conditions For Products and Related Services Contracts; Appendix B, Vendor’s Historically Underutilized Businesses Subcontracting Plan; Appendix C, Pricing Index; Appendix D, Service and Support Level Commitment; Appendix E, Corporate Subscriber Terms and Conditions; Exhibit 1, Vendor’s Response to RFO DIR-TSO-TMP-225, including all addenda; and Exhibit 2, RFO DIR-TSO-TMP-225, including all addenda; are incorporated by reference and constitute the entire agreement between DIR and Vendor. In the event of a conflict between the documents listed in this paragraph, the controlling document shall be this Contract, then Appendix A, then Appendix B, then Appendix C, then D, then E, then Exhibit 1, and finally Exhibit 2. In the event and to the extent any provisions contained in multiple documents address the same or substantially the same subject matter but do not actually conflict, the more recent provisions shall be deemed to have superseded earlier provisions.

2. Authorized Exceptions to Appendix A, Standard Terms and Conditions for Product and Related Services Contracts, Section 5. Intellectual Property Matters is hereby deleted and restated in its entirety as follows

At present, no development of new code or other customization, Intellectual Property is contemplated under this contract. At such time as Vendor and Customer agree to a scope of work involving new code development, the parties agree to negotiate applicable Intellectual Property provisions.

3. Appendix C, Pricing Index, is hereby restated in its entirety and replaced with Appendix C, Pricing Index attached hereto.

4. Appendix D, Service and Support Level Commitment is hereby added in its entirety.

5. Appendix E, Corporate Subscriber Terms and Conditions is hereby added in its entirety.

All other terms and conditions of the Contract as amended, not specifically modified herein, shall remain in full force and effect. In the event of conflict among the provisions, the order of precedence shall be Amendment Number 1, and then the Contract DIR-TSO-3149.

IN WITNESS WHEREOF, the parties hereby execute this Amendment Number 1 to be effective as of the date of last signature, but in all events not later than August 31, 2015.
