This Amendment Number 1 to Contract Number DIR-TSO-3526 (“Contract”) is between the Department of Information Resources (“DIR”) and Rhyan Technology Services, LLC (“Vendor”). DIR and Vendor agree to modify the terms and conditions of the Contract as follows:

1. **Contract, Section 2. Term of Contract**, is amended by the addition of the following:

DIR and Vendor hereby agree to extend the term of the Contract for one (1) year through August 2, 2019, or until terminated pursuant to the termination clauses contained in the Contract. The contract will renew automatically in one-year increments for one (1) additional year under the same terms and conditions unless either party provides notice to the other party 60 days in advance of the renewal date stating that the party wishes to discuss modification of terms or not renew.

Additionally, the parties by mutual agreement may extend the term for up to ninety (90) additional calendar days.
