

**Amendment Number 1**

This Amendment Number 1 to Contract Number **DIR-TSO-3717** (“**Contract**”) is between the Department of Information Resources (“**DIR**”) and Rightway Connections of Texas, Inc. (“**Vendor**”). DIR and Vendor agree to modify the terms and conditions of the **Contract** as follows:

1. **Contract, Section 2. Term of Contract**, is hereby amended by adding the following to the end of that section:

DIR and Vendor hereby agree to extend the term of the Contract for one (1) year through January 20, 2019 or until terminated pursuant to the termination clauses contained in the Contract. The Contract will renew automatically in one-year increments for two (2) additional years under the same terms and conditions unless either party provides notice to the other party sixty (60) calendar days in advance of the renewal date, stating that the party wishes to discuss modification of terms or not renew.

Additionally, the parties by mutual agreement may extend the term for up to ninety (90) additional calendar days.
