

**AMENDMENT NUMBER 3
TO
CONTRACT NO. DIR-SDD-1685
BETWEEN

This Amendment Number 3 to Contract Number DIR-SDD-1685 (“Contract”) is between the Department of Information Resources (“DIR”) and Cogniserv, LLC (“Vendor”). DIR and Vendor agree to modify the terms and conditions of the Contract as follows:
